We are very pleased to invite you to the International Scientific Conference on DIRECTIONS OF CHANGE IN PUBLIC ADMINISTRATION which will be held in the Old Hall of the Cracow University of Economics on 19 June 2017.

The idea behind the Conference is that there is a need to connect the domains of science and practice in those areas of public administration – especially in the field of delivery of public services – that have recently undergone rapid change caused, on the one hand, by increasing social expectations and on the other by the constraints of budgetary realities as well as regulations governing the absorption of EU funds. These factors have implications for the development and application of legislation in the areas of administrative, financial, public procurement, civil and labour law. Hence, the main purpose of the Conference is to provide a forum for exchange of ideas between representatives of theory and practice.

In the Conference research papers focused among others on:

- development and application of effective administrative and legal solutions,
- broadly understood financial law, including new rules governing the acquisition of European funds and their spending,

- innovative public procurement procedures and public-private partnerships,
- new solutions in the field of clerical law,

it will be necessary to make proposals *de lege lata* and *de lege ferenda* in order to give the scientific effects of the Conference a practical dimension.
